



Mgr Kevin McGinnell – Chair

Monsignor Kevin McGinnell has been Episcopal Vicar for Education for the Roman Catholic Diocese of Northampton since 2000, previously being Director of RE (1993-2000) and Adviser for RE for Buckinghamshire and Berkshire (1990 – 93). He is Parish Priest at Holy Ghost Parish, Luton and is also Chair of the Diocesan Liturgical Commission and Chair of the English Language Liturgical Consultation, Joint Liturgical Group (JB). He is member of the Bishops' Conference Committees for Education and Spirituality. Monsignor Kevin's background is in Catholic secondary education in Corby, Redditch, and London. He was appointed a Director of Duns Scotus Trust in January 2013 and is the current Chair.
